GSS Harmonised Principle

About this document

This document forms part of a series of GSS Harmonised Principles, designed to provide approved harmonised questions, definitions and outputs for a variety of social and business related topics. The use of harmonised questions, definitions and outputs will provide greater consistency for survey producers and comparability when using data.

It is important to note that when collecting data about national identities, a national identity question should be asked along with but separately to an ethnic group question.

In addition to these principles, there is also the Ethnicity and Identity Guidance: 'Ethnic group statistics: A guide for the collection and classification of ethnicity data' which offers assistance for anyone involved in collecting and presenting ethnicity, national identity and religion data. The new guide will be published shortly.

This is Version 4.4 published in June 2017

This document has been updated to Version 4.4 to reflect the change away from 'Primary Principles' and 'Secondary Principles' to 'GSS Harmonised Principles'. There has been no change to the harmonised questions.

Previous versions:

Version 4.3 published in February 2017

This document was updated to Version 4.3 to add the word 'previous' to the heading for Box B1 at Annex B. This removes the ambiguity about which is the current harmonised question.

Version 4.2 published in May 2015

This document was updated to Version 4.2 to correct minor formatting errors and to change the term *'Harmonised Standards'* to *'Harmonised Principles'* as agreed by the National Statistics Harmonisation Group.

Version 4.1 published in August 2011

This document presents the new recommended principles for the National Identity and Religion questions. These harmonised principles have been approved by the GSS Statistical Policy and Standards Committee and ratified by the Heads of Profession. They were developed through consultation with the Ethnicity, Identity, Language and Religion sub-group following a two year programme of work.

Version 4.0 published in December 2008.

This document was updated to Version 4.0, to reflect changes in the format of the document placing 'Inputs' before 'Outputs'

Version 3.0 published in April 2008.

Contact details for the Harmonisation Team have also been updated.

Version 2.0 published in October 2005.

This version now includes the standard question to collect data on National Identity.

Version 1.0 published in November 2004.

Version 1.0 was part of a series that replaced the Harmonised Concepts and Questions document. We had worked to make our guidance easier to find and clearer to use. Other than the formatting and layout changes, there were no new changes to questions or outputs in this version.

Introduction

GSS Harmonised Principle

With the new devolved administrations, there has been an increasing interest in 'national' consciousness with many people wanting their 'national' identity to be acknowledged. As a result a 'national identity' question has been developed to take this into consideration. The question should be used in addition to the ethnic group question whenever there is a need to collect data about national identities; for instance, when respondents classify themselves as English, Scottish, Welsh, Irish, British, or another national identity.

National identity should be asked as a separate question in addition to ethnic group. This is because our research has led to the conclusion that classifying ethnic group is best achieved separately from national identity. There is an order effect that is best managed by asking national identity before ethnic group, as this allows respondents to describe themselves as English, Welsh, Scottish, etc. Research suggests that people were happier when asked about their national identity first.

Inputs

The national identity question should be asked as a separate question in addition to the ethnic group question. Research has shown that classifying ethnic group is best achieved separately from national identity. It is recommended that the national identity question is asked immediately before the ethnic group question in surveys. The previous national identity question is provided in Annex A (Box A.1)

The order of response categories should be changed depending on where the question is being asked. The recommended orders of categories are given in Box 1.

Inputs

It is recommended that a show card is used in interviewer-led surveys. Where this is not possible (e.g. telephone interviews), the response categories should be read out by the interviewer in the same order as they appear on the show card.

Where cross-country comparability is a priority above comparability with respective census questions, categories for a single UK question have been recommended in Box 2. It is still recommended however that the category orders follow those presented in Box 1. Although there is a slight variation of response categories for Northern Ireland, an Irish category should be located between the 'British' and 'Other' categories. To comply with the Good Friday Agreement, the National identity question should be asked in a way that no-one from Northern Ireland should be forced to choose between being British, Irish and Northern Irish.

The show card should include the instruction 'Please choose all that apply' in addition to being read out by the interviewer. The instruction 'please describe' should also be included on the show card following the 'other' response option (see sample show card in the Annex). This should be in non-bold font. These instructions should also be included on paper-based surveys.

Inputs

Where a single question on religion is required for data collection in the UK, religious affiliation is the recommended concept to measure. The previous harmonised religion question is provided in Annex B (Box B.1)

It is not recommended that a single Christian category is used across GB or the UK. Breakdown for the Christian denominations that should be used in Scotland and Northern Ireland are provided in Box 5.

It is recommended that a show card is used in interviewer-led surveys in GB. Where this is not possible (e.g. telephone interviews), the response categories should be read out by the interviewer in the same order as the appropriate show card.

The instruction 'please describe' should be included on the show card following the 'any other religion' response option. This should be in non-bold font. This instruction should also be included on paper-based surveys

Use of a show card is not recommended in Northern Ireland. The interviewer should read the question and wait for a spontaneous response. If a response is not forthcoming, the interviewer may prompt using the categories provided in Box 5 for Northern Ireland. Please note that the religion question on the Labour Force Survey for Northern Ireland asks about religious denomination, with the main difference being nine categories, where 'other protestant' and 'other religion' are combined compared to sixteen on the harmonised principle question.

It is recommended that UK comparisons are not made using census data as the questions used in the censuses differ. Scotland and Northern Ireland censuses ask a question on 'belonging', whilst England and Wales ask about affiliation.
